Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2018-19 educational progress for Quest High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. If you have any questions about the AER, please contact Principal, Mark Hiltunen for assistance.

For the 2018-19 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has a student subgroup performing at the same level as the lowest 5% of all schools in the state. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school "HAS NOT BEEN GIVEN ONE OF THESE LABELS".

The key challenge for Quest High School includes recovering students that are not on track to graduate with their graduating class. The key to our success with at-risk students is a dedicated administration that supplies our program with the available resources to be successful, as well as a dedicated teaching staff that truly loves the North Branch community as well as our Quest learning community. While the state average for graduation rates is typically between 30-35%, Quest aims to meet the state standard of 80%. Quest currently typically falls between 60-80% for on-time graduation rates, and an overall graduation rate above 90%. Decisions regarding the school improvement plan and its implementation revolve around accomplishing this goal, in conjunction with data gathered from the PSAT/SAT/M-Step test results. Researched based and vetted academic strategies will be evaluated before, during, and after implementation.

State law requires that we also report the following additional information:

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

Students are assigned to Quest High School based on being at-risk to graduate at North Branch High School, or by applying as a school-of-choice student from outside of our

district. A student is determined to be at-risk when they have failed 3 or more classes, and can no longer graduate with their cohort without credit recovery.

- THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN Quest High School is the "implementing" phase of our school improvement plan, as several areas of the school improvement plan have moved to that phase, working toward "full implementation".
- 3. A BRIEF DESCRIPTION OF EACH SPECIALIZED SCHOOL Quest High School is a specialized school in that it serves students that are at-risk of failing out, or dropping out of a traditional high school. Students spend half their day at Quest, and either split the other half of their day at the Lapeer County Educational and Technology Center or our traditional high school.
- 4. Quest High School follows the recommended core curriculum and requirements are identical to our traditional high school.

THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS Students participate in the PSAT/NMSQT, PSAT 10, SAT, M-STEP, and the MME along with local assessments to identify gaps in the curriculum and make necessary adjustments ensuring our students success. These results are entered in our district student database. - 6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES

Approximately 15% of students were represented by parents at our parent teacher conferences. Strict attendance was taken. Any student not represented attended an academic counseling meeting to ensure that the student was provided with feedback on their graduation plan.

None of the approximate 45-55 students enrolled at Quest participated in dual enrollment classes. Students have this option, but their reality of being credit deficient does not typically allow them room in their schedule for college courses. Because of the nature of alternative education, we do not offer advanced placement classes. Our students have the opportunity to enroll on AP classes at the traditional high school if deemed academically appropriate.
